The National Immigrant Justice Center (NIJC) is dedicated to ensuring human rights protections and access to justice for all immigrants, refugees, and asylum seekers.

Based in Chicago and with five offices across the country, NIJC provides direct legal services to and advocates for all immigrants through policy reform, impact litigation, and public education. Since its founding more than three decades ago and thanks to the support of thousands of pro bono attorneys from the nation's leading law firms NIJC has been unique in blending individual client advocacy with broad-based systemic change.

Pro bono representation can save lives. Without an attorney, people may be separated from their family or sent to dangerous situations. NIJC pro bono attorneys defend the legal rights of immigrants regardless of background and transform the immigration system to one that affords equal opportunity for all.

How NIJC's Pro Bono Programs Work

An immigrant contacts NIJC and needs an attorney



NIJC staff conduct an in-depth case assessment



 If NIJC accepts the individual's case for representation and the individual retains NIJC, NIJC begins to seek pro bono placement



 A pro bono attorney team accepts the case and becomes responsible for all case preparation and representation, but NIJC continues to provide ongoing, in-depth support throughout the life of the case



 Each case accepted by a pro bono attorney team allows NIJC to accept one new pro bono case for representation

Our Pro Bono Partnership

- NIJC remains of counsel and provides in-depth training, attorney support, document review, and technical assistance throughout the life of the case.
- NIJC expects pro bono counsel to prepare the case with the client, provide any necessary interpreter services, and represent the client before federal agencies.
